## SCI China Market Update – December 2017

Dear friends,

Season's greetings! I just returned home from Prague, the Czech Republic, where I was helping our client, Hastings Manufacturing, and its investor, RFE Investment, to close an important acquisition. Hastings acquired 100% of Piston Ring Komarov (PRK) from two Chinese owners - Dalian Rubber & Plastic Machinery Co. (DXS), which owned 90% of PRK, and Tianjin Machinery Import & Export Co., Ltd., which owned the remaining 10% of PRK.

Just imagine the difficulties of such an acquisition – a U.S. company buying a Czech Republic manufacturer owned by two Chinese companies. The deal required navigating three national cultures and their legal, business and even environmental systems, all against tough deadlines. Top-level attorneys from the U.S., China and Czech had to be involved from the very beginning. Moreover, the two former Chinese owners are major state-owned companies in two different Chinese cities. That's where SCI came in. For over a year, we helped Hastings and RFE Investment to deal with these huge Chinese bureaucracies.

Our work required a lot of patience and "Guanxi" as we negotiated with the Chinese seller and attorneys. But we were able to narrow the gaps in understanding and fix problems that allowed the deal to move forward. The deal finally closed on December 15th. Soon after, I was so pleased to receive the following email from Jim Parsons, Managing Director of RFE Investment.
